With reference to your application dated 25.05.26 and subsequent school inspection in this regard, I hereby convey the grant of Recognition to **Satdham Vidyamandir, Village Pardhol, Behind Zank Bus Stand, Naroda-Dahegam Road, Ahmedabad 382330** (Name & Address of school) for **class I to VIII** standard for the period **Five years** (no. of years) from the academic year **2026-2027 to 2030-2031** in compliance to section 18 of Right of Children to Free and Compulsory Education, Act, 2009 & rule 2012 of (State Act/ Rule).

The above recognition is subject to the following conditions:-

1. The temporary recognition accorded to the school is valid from the academic year **2026-2027 to 2030-2031** and is to be renewed at an interval of every **Five years**.
2. The grant of recognition is available initially for classes I to VIII standard and to be extended for Secondary /Senior Secondary classes subsequently in due course of time.
3. The school shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 and the **RTE Act, 2009 and Gujarat State Education Rules** (State Education Act/ Rules).
4. The school shall admit in pre-school / class I to the extent of **25% EWS quota** (%age) of the strength in each class, children belonging to Weaker Section and Disadvantaged Group in the neighborhood and provide free and compulsory elementary education till its completion.
5. The school shall maintain a separate bank account for the purpose of reimbursement.

6. The school shall not collect any capitation fee and subject the child or his or her parent or guardian to any screening procedure.
7. The school shall not deny admission to any child, -
 - a. For lack of age proof if such admission is sought subsequent to the extended period prescribed for admission.
 - b. On the ground of religion, caste or race, place of birth or any of them.
8. The school shall ensure that,-
 - a. No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
 - b. No child shall be subjected to physical punishment or mental harassment.
 - c. No child is required to pass any board examination till the completion of elementary education.
 - d. Inclusion of students with disabilities/ special need as per provision of the **Right of Children to Free and Compulsory Education Act, 2009** and the **Rights of Persons with Disabilities Act, 2016.** (rule/ clause of State Act).
 - e. The teachers are recruited with minimum qualifications as laid under **National Council for Teacher Education (NCTE) under Section 23 of the RTE Act, 2009 and as per the Gujarat State Education Rules.** (Rule/ clause of the state Act).
 - f. The teachers perform his duties specified under **Section 24 of the Right of Children to Free and Compulsory Education Act, 2009.** (rule/ clause of the state Act).
9. The school shall follow the syllabus on the basis of curriculum laid down by the appropriate authority, i.e., **NCERT/SCERT/CBSE**, as applicable.
10. The school shall maintain the standards and norms as specified under the provisions of the **Right of Children to Free and Compulsory Education Act, 2009** and the **Gujarat Right of Children to Free and Compulsory Education Rules, 2012.**
11. No unrecognized classes shall be run within the premises of the school or outside in the name of the school.
12. The school building plan must have been approved as per the applicable rules and Government Orders. The school building and other structures and the grounds shall be used only for the purposes of education and skill development. Construction work within the school premises shall not be carried out during school working hours, and all safety measures shall be ensured by the school management.

13. The school is run by a society registered under the **Societies Registration Act, 1860 / Gujarat Public Trusts Act, 1950** (whichever is applicable), or a public trust constituted under any law for the time being in force.
14. The school is not run for profit to any individual, group, association of individuals, or any other persons.
15. The accounts of the school shall be audited and certified annually by a qualified Chartered Accountant, and proper books of accounts and statements shall be maintained.
16. The school shall furnish such reports and information as may be required by the competent authority from time to time and shall comply with such instructions of the State Government or competent authority to ensure continued fulfilment of recognition conditions and removal of deficiencies, if any.
17. English, Hindi, Sanskrit, and Gujarati shall be taught as language subjects in standards I to X in accordance with the provisions of the **Gujarat Secondary and Higher Secondary Education Act, 1972** and applicable rules from the academic session for which recognition is granted.
18. The school shall abide by the provisions of the **Right of Children to Free and Compulsory Education Act, 2009** and the **Gujarat Right of Children to Free and Compulsory Education Rules, 2012**, as amended from time to time.
19. The certificate of recognition issued by the department shall be subject to the fulfilment of deficiencies, if any, pointed out by the department at any stage or time.
20. The school management shall rectify the deficiencies pointed out in infrastructure, academics, or administration by the competent authorities within the stipulated time.
21. The school management shall apply for renewal of recognition at least **three months prior to the expiry** of this order to the **District Education Officer, Ahmedabad, Gujarat** (or the concerned certificate issuing authority).
22. The school management shall follow all directions issued by the Government/Department from time to time, keeping in view the safety and security of the children and the overall administration of the school.
23. The recognition shall be liable to be withdrawn if any contravention of the provisions of the Act, Rules, or conditions of recognition is found and proved.
24. The school management shall bear full responsibility in case of any legal dispute arising in this regard. The management shall not seek affiliation with any other Board without obtaining a **No Objection Certificate (NOC)** from the concerned State Government/competent authority.
